Whereas in terms of Section 14(1) of the NCTE Act, 1993 Prism School of Education, Plot no. 207,211, Street - Main Road, Post - Utai, Dist - Durg, Chhattisgarh - 491107, (Code No. WRCAPP1640) 07.10.2011 to the Western Regional Committee of the NCTE for grant of recognition B.Ed. course with an annual intake of 100 seats.

- 2. AND, WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution has adequate financial resources, accommodation, library, qualified staff, laboratory and that it fulfills such other conditions required for proper functioning of the institution for **B.Ed.** course as determined by regulations.
- Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to Prism School of Education, Plot no. 207,211, Street Main Road, Post Utai, Dist Durg, Chhattisgarh 491107, (Code No. WRCAPP1640), for starting B.Ed. course of Secondary level of 1 year duration with an annual intake of 100 from the academic Session 2014-15, as per the orders of the Hon'ble Supreme Court dated 13.12.2012 in W.P. (Civil) 276/2012.
- 4. Now, the applicant institution has filed a Civil Appeal (No. 9078/2012) under W.P. (C) No. -411/2013 in the Hon'ble Supreme Court of India and subsequently in compliance of Hon'ble Supreme Court of India Order dated 03.07.2013 recognition to the institution Prism School of Education, Plot no. 207,211, Street Main Road, Post Utai, Dist Durg, Chhattisgarh 491107, (Code No. WRCAPP1640), for B.Ed. course is granted with 100 intake from the academic session 2013-14.
- 5. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition Norms & Procedure) Regulations, 2009.
- 6. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.
- 7. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.
- 8. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
- 10. If, at any time, either on *sue-moto* inspection or on any representation received from any person, the WRC, NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or
